

Letter of authorization — Read Only and Trading or Ownership

A client may grant their Power of Attorney (POA) three types of online account access: view only, online trading authority, or online ownership-level authorities. **In order to proceed, the POA paperwork must be approved by Merrill, the POA must have an online Merrill login, AND the** <u>client</u> must complete this form (not the POA).
