Style Manager Strategy and PAS Style Manager Strategy Step Out Information Document

Merrill Lynch, Pierce, Fenner & Smith Incorporated ("Merrill", "we" or "us") offers third party Style Manager Strategies ("strategies") through the Merrill Lynch Investment Advisory Program ("MLIAP"), (the "Program"). Additionally, Bank of America N.A. ("BANA", "we," or "us") offers third party Style manager Strategies ("strategies") through the Private Bank Select Portfolio Solutions ("SPS"), (the "program"). We may, in some instances, allow a third party Style Manager ("Investment Manager") to execute trades on behalf of Program clients. Investment Managers that have the authority (full or limited) to trade through a broker, dealer or bank other than Merrill or its affiliates (an "Unaffiliated Investment Firm") or in certain circumstances with Merrill or its affiliates, for all or portion of the trades are referred to as "Discretionary Managers". This document provides information to clients about Discretionary Managers that have either regularly or on a limited basis traded through Unaffiliated Investment Firms during the time period noted below. This practice is known as "trading away", and such trades by Discretionary Managers with Unaffiliated Investment Firms are commonly referred to as "step out" trades.

Trading-Away and Step-Out Trades

Certain Discretionary Managers and Premium Access Strategies ("PAS") Managers have historically executed all or a portion of their trades as "step outs". Frequently, these trades have been for fixed-Income or other securities for which trading-related charges and costs (e.g., mark-ups/downs, dealer spreads) are charged by the executing broker-dealer. These trading-related charges and costs are included in the net price of the security and are charges and costs that are in addition to the client's Program Fee. Clients should understand that they, rather than Merrill, its affiliates, the Discretionary Manager or PAS Manager will bear the cost of these trading-related charges and costs. In addition, these trading-related charges and costs will not be reflected as separate charges on clients' trade confirmations or account statements. We will undertake, at the client's written request, to obtain the amount of this remuneration for a given transaction in the client's account.

If the Discretionary Manager or PAS Manager executes "step out" transactions for certain equities and other securities with an executing broker-dealer that is an Unaffiliated Investment Firm, clients will not have to pay trading-related charges and costs (e.g., commissions and mark-ups/downs) charged by the Unaffiliated Investment Firm except for transactions in foreign ordinary shares and American Depositary Receipts ("ADRs"). Information on Trading Away in the Program

Below is a list of the Discretionary Managers and PAS Managers that have indicated to us that they exercised their full or limited discretion to execute trades along with associated cost for Program accounts through an Unaffiliated Investment Firm in 2023.

The information provided below is based solely on the information that has been provided to us by the Discretionary Managers and PAS Managers. We have not independently verified such information. A Discretionary Manager or PAS Manager's past trading away practices is not a guarantee that such Discretionary Manager or PAS Manager will continue to follow the same practices in the future. It is possible that a Discretionary Manager or PAS Manager that did not trade away from Merrill for the below time period (and therefore is not listed) may perform step out trades in the future or that the Discretionary Managers or PAS Managers listed below may perform step out trades more or less frequently than indicated during the previous time period. Therefore, the fees or additional expenses associated with trades placed by a Discretionary Manager or PAS Manager and executed by an Unaffiliated Investment Firm may be greater than in previous periods.

Clients should contact their Merrill financial advisor or Private Bank private client advisor to obtain additional information about the trading practices of Discretionary Managers.
