  - a. My basis determination method election applies to all future acquisitions of shares of stock in any mutual funds specifically listed above (this includes an acquisition of such shares by purchase, transfer, reinvestment or corporate action); OR
  - b. If my basis determination method election applies to all mutual funds in an account (if box is checked above), then my election applies to all future acquisitions of shares of stock in any mutual fund in that account (this includes an acquisition of such shares by purchase, transfer, reinvestment or corporate action).

**3.** I acknowledge the following:

- a. If this notice is received prior to the first sale of averaged tax lots in any of my holdings, my First In, First Out (FIFO) original cost will be restored and will be reflected going forward.
- b. If this notice is received after the sale of any average cost tax lots, then the average cost at the time will be locked in and treated as my new FIFO original cost going forward. All subsequent purchases will show their unique original FIFO cost that will have no impact on the previously averaged lots.
