The team at Merrill Lynch is dedicated to helping you pursue the investment outcomes that are most meaningful to you. e-Signature on MyMerrill.com® is a free, secure service which allows you to electronically sign and submit forms online. It serves as an alternative to your “ink signature” on a document. This will streamline the flow of documents sent from and to your Financial Advisor through the Secure Message Center communication tool within MyMerrill.

e-Signature is available in two different avenues - you have the ability to initiate and submit an e-Signature request or your Financial Advisor may send it to you for completion!

Signing forms for multiple users



When necessary, forms can be sent to all signers on the account for their electronic Signature. Each signer will receive an email directing them to their Secure Message Center within MyMerrill.

When there are 2 signatures required:

- If the co-signer is immediately available, the logged in signer can select 'Complete form now' and they will be immediately logged out of MyMerrill for the co-signer to log in* and complete the form.

OR

- If the co-signer is not available, the logged in signer may select 'Send to co-signer' to send a reminder notification to the co-signer on the request. A personal message can also be included in the reminder notification.

When there are 3 or more signatures required:

- The order of co-signers can be changed by the logged in signer by dragging and dropping the signers in the preferred order. A personal message can also be included in the reminder notification.

Signer status updates can be viewed at any time by clicking on the button in the original notification received.

* Co-signers without a user friendly ID will be prompted to use an alternate authentication method of entering their Social Security Number and Date of Birth to electronically sign documents. Notifications are sent to the email address on file or the email address entered by the first signer.
